5 Module Overview

The purpose of this module is to develop your existing professional attributes and skills gained through work-based experiential learning in the areas of building procurement and contract administration. This includes critical analysis of the architect's responsibility to society and the profession, the legal and legislative context for practice and the business and management processes involved in running and developing a successful business.

The module will run from the middle of February until the middle of May. The outcomes of the module will be supported by the 'Building Procurement and Contract Administration' lecture programme delivered over two lots of two days during February and March and supported with individual and group tutorial input.

During the first four weeks you will focus on developing your knowledge and understanding of the legal framework relating to architectural practice, construction and contract law and dispute resolution. Following this and during the second four-week period the emphasis will be on identifying and analysing the processes involved in comparing and selecting an appropriate construction contract and the processes and procedures for effective project management and contract administration.

Your academic learning should be supported by your continuing professional experience in practice and through self-guided group work facilitated by your learning sets. You will be expected to undertake your own research and investigations as part of your preparation for the scenario-based open book examination. The open book examination paper is designed to test your knowledge and skills in providing individual appropriate solutions to a range of contract related problems. The paper will reflect the lecture programmes discussed above and draw upon your professional experience and judgment.
