6 Indicative Content

- Pharmacology, therapeutics, pharmacokinetics pharmacodynamics
- Physiological action of drugs on the human body
- The clinical activity of independent prescribing: accurate assessment, relevant physical assessment skills, history taking and consultation, diagnosis decision-making, therapy including referral
- Managing information maintaining records and appropriate documentation.
- Numeracy and drug calculations
- The legal, legislative, professional and ethical aspects of prescribing, adhering to professional codes of conduct/ethics within role boundaries and team context.
- Influences and psychology of prescribing, considering the patients/clients experience and involvement, adherence and non-adherence
- Impact of co-morbidity and other treatments on prescribing and patient management, the national and local context of prescribing.
- The quality assurance aspects of the prescribing activity, using robust evidence and clinical governance frameworks.
- Prescribing of unlicensed drugs, controlled drugs, off label prescribing and mixing of medicines identifying and reporting unexpected and adverse drug reactions
- Auditing, monitoring and evaluating prescribing systems and practice including the use of outcome measures.



- Identification and development of personal formularies
- The ethical issues, documentation, legal aspects and accountability related to prescribing medicinal products not regulated by the Care Quality Commission unlicensed drugs, controlled drugs, mixing medicines and off label prescribing.
- Methods for monitoring the patient including interpretation and responding to patient reporting, physical examinations and laboratory investigations.
